## SPEECH - PEOPLE - WORLD: SPEECH MANIPULATION IN DIFFERENT DISCOURSES

Cardinal socio-political transformations of the late XX and early XXI centuries, which shook the world community (changes in the geopolitical configuration of Europe, collapse of the USSR, Poland's accession to the European Union, globalisation processes) increased the interest of researchers in the spheres of management of life and mindset of the masses. Remarkable strengthening of the positions of the communicative activity-oriented and pragmalinguistic approaches to the study of linguistic phenomena and discursive practices led to intensive study of the widely understood manipulation in various spheres of communication. The need to investigate the mechanisms of speech manipulation in public discourse is determined by the prevailing current sociocultural situation, which is a favourable ground for modulation through a convincing word - through mass media, public stands or modern didactic instruments - ideological guidelines to a wide audience.

The purpose of the conference is to create a platform for the exchange of observations among scientists whose research (from the field of linguistics, eristic, psycho- and sociolinguistics, social psychology, sociology, jurisprudence, marketing and other disciplines) contribute to deepening the knowledge about the ways of speech manipulation in various types of discourse: political, medial, religious or didactic, both in the field of national and intercultural communication. The novelty of this project is to determine the mental-psychological affinity of carriers of different languages in a broad interdisciplinary study.

Topics of the conference include the following aspects:

- argumentation and manipulation in private and public communication;
- typology and hierarchy of persuasive genres;
- tactical and strategic planning of the utterance, interaction of the addressant and the receiver in the process of communication;

- specificity of speech influence in political, medial, religious, didactic discourses;
- linguistic-suggestive potential of communication in the global global network.

Other proposals for more aspects are welcome.

Conference languages: Russian, Polish, English.

Form of presentation: paper (time of speech 15 minutes, plenary paper - 20 minutes).

Conference materials will be published in the reviewed monograph.

The application, information about the author and the topic of the speech should be sent by 31

January 2018 to mcs@ug.edu.pl. Texts are accepted until May 30, 2018.

Registration fee is 440 zł. This amount includes:
